To the Animal Sheltering Services Board:

Attached please find the results of the New Mexico Animal Shelter Survey. Thank you for your patience as I have worked over the past months to provide comprehensive, accurate, and relevant data about New Mexico's animal shelters to this Board.

SURVEY ORGANIZATION

The survey is organized alphabetically by county. On the left-hand side of the survey the shelter name is listed in bold, followed by the county the shelter is located in and who owns/operates the shelter.

Next listed are the *animal intake* for the shelter, the *human population* of the area served (which is tied into the *contracts* category, described below), the *number of euthanasias*, and the *euthanasia per thousand* figure. Euthanasia per 1000 human population measures all euthanasia in shelters in a community. The number is the euthanasia, divided by the human population, multiplied by 1000. This formula is used nationwide to evaluate shelter data. In the case of Albuquerque Animal Services and Animal Humane Association of New Mexico, the euthanasias for these shelters were added together, then divided by the population of Bernalillo County, and finally multiplied by 1000. The calculation for all other shelters was the number euthanized, divided by the population of the area served, multiplied by 1000. The euthanasia per 1000 national average in 2005 was 14.8 per

1000. New Mexico's statewide average is 33.72, more than twice the national average.

The *contracts* category shows any additional areas the animal shelter provides services to. The UNM Bureau of Business and Economic Research was used to obtain human population figures based on what areas the shelter was serving. Native Nations populations are from the 2000 Census and all other human population figures are from 2006 population estimates.

SURVEY RESULTS

The results of the survey justify the existence of the Animal Sheltering Services Board (ASSB). Across the state, a diversity of budgets, facilities, and animal intake is seen. Based on the results, Animal Protection of New Mexico recommends the following:

- Ongoing surveys by the ASSB. These survey results may not be complete; there may be other shelters governed by the ASSB that I was unable to connect with. Further outreach to shelters may be necessary for comprehensive data collection. The Board may choose to include additional data for collection in future surveys, such as number of adoptions, a further breakdown on the types of animals taken in and euthanized, and the training status of employees. Compiling this data was time-consuming; if the Board could formalize a

process and make that known to shelters in advance, this may simplify collection of data for the survey.

- Capacity-building for animal shelters. In addition to the role spelled out for the ASSB in the Animal Sheltering Services Act, the Board should work to empower shelters to serve the neediest animals in their community effectively. Euthanasia training is the beginning of this list, but high-volume, low-cost spay-neuter programs should also take a priority as the best way to reduce animal intake. Community investment is necessary for the success of New Mexico's animal shelters as well: animal training, foster programs, volunteerism, coordinating with rescue groups, feral cat trap-neuter-return, and disaster planning are just a few of the many programs the ASSB can support in the future.

DATA VERIFICATION

Every attempt was made to verify the data before providing it to the board. Initial interviews were conducted over the phone, and then letters were mailed to shelter stakeholders asking them to review the information collected. Below is a list of 16 of the 35
