AN ORDINANCE AMENDING ORDINANCE NO. 173 OF (THE ANIMAL WELFARE ORDINANCE), ADDING DEFINITIONS TO SECTION 2. (DEFINITIONS) AND ADDING A NEW SUBSECTION (4) TO SECTION 6 (J)- (LICENSING AND VACCINATION REQUIREMENTS FOR DOGS AND CATS) OF THE VILLAGE OF LOS RANCHOS DE ALBUQUERQUE.

BE IT ORDAINED BY THE BOARD OF TRUSTEES, THE GOVERNING BODY OF THE VILLAGE OF LOS RANCHOS DE ALBUQUERQUE, THAT THE ANIMAL WELFARE ORDINANCE IS HEREBY AMENDED AS FOLLOWS:

Section 2 - Is hereby amended by the addition of definitions as follows:

SECTION 2. DEFINITIONS

ALTER means to render an Animal incapable of reproduction.

INTACT means a dog, cat or ferret over six months old that has not been altered.

Section 6.J. - Is hereby amended by the addition of a new subsection 4 as follows:

SECTION 6. J LICENSING AND VACCINATION REQUIREMENTS FOR DOGS AND CATS.

- 6.J. OWNER RESPONSIBILITIES. The owner shall:
- 4) No person shall own or possess an Intact dog, cat or ferret over the age of six months old without a valid Permit ref. Section 10.F & G. The owner of altered dog(s), cat(s) or ferret(s)' proof of sterilization by a licensed Veterinarian will be available for inspection by the ACO.

COMPILING CLAUSE

This ordinance shall be incorporated in and compiled as part of the Municipal, Code of the Village of Los Ranchos de Albuquerque.

RESOLUTION ESTABLISHING FEES FOR INTACT ANIMALS IMPOUNDED IN THE VILLAGE OF LOS RANCHOS DE ALBUQUERQUE

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF LOS RANCHOS DE ALBUQUERQUE THAT:

WHEREAS, the Village of Los Ranchos de Albuquerque adopted Ordinance No. 205 amending Ordinance No. 173 adding definitions of "Alter" and "Intact" and adding a section on "Owner Responsibility"; and

WHEREAS, the amendments state that all pet owners of intact animals must obtain a permit for their cat, dog or ferret that has not been altered; and

WHEREAS, the Village has received requests from pet owners for said permit; and

WHEREAS, the Village encourages pet owners, non-breeders, to spay or neuter their dogs, cats and other pets to reduce the number of unwanted animals.

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees, the Governing Body of the Village of Los Ranchos de Albuquerque, to establish the following policy and fees for intact animals:

POLICY:

Prior to issuing the permit, the owner must present a veterinarian's certificate that the animal(s) is current with all required vaccinations and that the pet has an identification microchip. The Intact Animal Permit shall be revoked without refund upon the second impoundment of the animal.

FEES:

Initial Permit for Cat, Dog or Ferret: \$75 Renewal Annual Fee \$35
