

Shannon Marshall Chief Operating Officer A recent Lake Research Partners survey shows that **registered voters in New** Mexico overwhelmingly oppose horse slaughter for human consumption in general, and are opposed to a horse slaughter plant in their communities as well. Placing a horse slaughter plant in New Mexico clearly would go against public opinion. Opposition is broad and deep and extends across every demographic group including regions and partisan groups. The major findings are as follows:

• Seven in ten registered voters in New Mexico (70%) disapprove of allowing American horses to be slaughtered for human consumption.ⁱⁱ In fact, over half (55%) of all registered voters *strongly* disapprove, while just 22% say they approve of slaughtering American horses for human consumption.

• The overwhelming opposition to horse slaughter crosses all demographic groups.



Seventy-four percent of registered Democrats oppose horse slaughter, along with 68% of voters registered with third parties or independent, and 66% of registered Republicans. Furthermore, at least 67% of voters within each of the three major geographic regions disapprove of allowing horses to be slaughtered for human consumption.

 Opposition to horse slaughter for human consumption also crosses racial and ethnic lines with 76% of Hispanics and 67% of Anglos opposing horse slaughter.

Seventy percent of registered voters say they would oppose a horse slaughter facility in their community (just 20% would support a facility).^{III} Like opposition overall, opposition to a facility in their community extends across the state and partisan groups.

- 76% of Hispanics and 66% of Anglos oppose a facility in their community.
- 72% of voters under age 50 and 69% of voters over age 50 oppose a facility in their community.
- 78% of registered Democrats, 72% of independents, and 58% of registered Republicans oppose a facility in their community.
- 77% of registered voters in the Metro North, 65% of voters in the Non-Metro North, and
 63% of voters in the South oppose a facility in their community.
- Voters across all areas of New Mexico, including rural areas, small towns, suburbs and cities oppose horse slaughter facilities in their state: 76% of voters in cities, 76% in small towns, and 62% in rural areas oppose a slaughter facility in their community.

In sum, there is a broad consensus among registered voters in New Mexico—as there is throughout the nation – opposing horse slaughter of American horses for human consumption, and standing strongly against a horse slaughter facility in their community.

ⁱ **Methodology**: Lake Research Partners designed and administered this telephone survey, using professional interviewers, with 403 registered voters. The statewide survey was conducted March 27-30, 2012. The margin of error for the total sample is +/-4.9 percentage points, and larger for sub-groups. The data were slightly weighted by gender and age to ensure a comprehensive representation of registered voters in New Mexico.
